### Dear Food Vendor

The Kettle Creek Music Festival is planning its Annual Music Festival in hopes to provide music and entertainment with a family atmosphere. Festival dates are; Aug.7, 8, 9, 2025. Gates open August 6<sup>th</sup> @ 8 AM for food and craft vendor set up. Request food Trailer vendors set up by 7 PM Wednesday.

Entertainment starts Thursday at 1 PM. Friday and Saturday entertainment starts at 11AM to 11 PM.

Location, Quiet Oaks Campground just off route 144 on Steward Hill Road between Tamarack and Cross Fork, Pa. 17729

The Music Festival Committee will require a list of food items you plan to sell before vendor approval is granted (write on back of form or enclose a list).

**NOTE: Attach copies of your Food License, Serve Safe Certificate and Liability insurance.**

Applications with payment are due back by June 1<sup>st</sup> 2024.

**Vendor space is \$ 50.00 per space, includes electric (for vending – 20 amps)**

**Vendor space is \$ 55.00 per space, includes electric (for vending – 30 amps)**

**Vendor space is \$ 60.00 per space, includes electric (for vending – 50 amps)**
